STALLION SERVICE CONTRACT FOR TRANSPORTED SEMEN 3 YEAR LIMITED LFG

enters into this agreement with Confidento Partners, also referred to as "Farm". Above named is referred to as "Purchaser" in this agreement. "Purchaser" is the owner or lessee of the mare to be bred, named below.

This service agreement is for the stallion **CONFIDENTO** to breed the mare named _____

"A photocopy of the mare's registration papers must accompany this contract."

Purchaser agrees to pay the Farm a non-refundable Stallion Service Fee of _____ (+GST) [\$500.00 booking fee included] is payable before semen is shipped. **First collection and disposable shipping container are included in Stallion Service Fee** (all shipping fees are the responsibility of mare owner).

An additional collection fee of **\$250.00 (+GST) with Purolator** or **\$385.00 (+GST) for shipment by Air** is required for each additional collection. This fee must be received by the Farm before the collection date.

I understand that my mare must be examined by a licensed veterinarian with an ultrasound machine at about 14 and about 50 days after the last breeding day. Confidento Partners will need to be notified of her pregnancy status at that time by phone or email so a breeding certificate can be issued after the breeding season, before foaling.

An intrauterine culture is recommended if you have an older mare that was bred before, a mare that had a difficult birth/retained placenta, aborted last pregnancy or if you have any other reasons to be suspicious of uterine health. We **do not** require proof of a clean culture. We do expect you follow your veterinarian's recommendation for best results.

The "Farm" assumes responsibility to have available for pick-up or deliver live semen in viable condition at the time of delivery to the approved shipping address. This semen must be administered by a licensed veterinarian or by a breeding technician approved by "Farm" only to the mare named in this agreement. If semen shipments are used for a mare other than named in this agreement without approval from the "Farm" the standard posted breeding fee and completed contract shall be due and submitted to Confidento Partners immediately. This approval constitutes a part of the contract and without it the live foal guarantee is null and void. The semen must be administered on the day of delivery or the "Farm" shall be considered to have fulfilled the contractual obligations. This contract cannot be assigned or transferred by Purchaser. There shall be no right of return to the Stallion if the Mare is sold or otherwise changes ownership after having been served by the Stallion unless otherwise stated.

In the event of stallion death or the inability to produce and ship viable semen from the stallion contracted for this service, "Farm" shall substitute this fresh semen agreement for either fresh or frozen semen any other Stallion owned by the "Farm".

In case the mare does not conceive, "Farm" guarantees return privileges for the contracted mare during the course of

the breeding season (May15th- August 15th) and guarantees return breeding privileges for the two seasons following the initial breeding season (total of three years) to insure "Purchaser" that a foal is produced as a result. The Purchaser recognizes the Farm's right to require a negative intrauterine culture certificate before the Mare's return to service. A mare may be substituted with permission of the "Farm" and a statement from a licensed veterinarian confirming the original mare on contract is barren. This contract is only transferable upon approval with written permission of "Farm". Embryo transplants are also prohibited without written permission of the farm.

Live Foal Guarantee - If the Mare does not settle during the Present Breeding Season; if the Mare is examined in foal but becomes barren during gestation or if the Mare subsequently produces a live foal that is unable to stand alone and nurse within 72 hours of foaling, and subsequently dies, "Purchaser" shall be entitled to above-mentioned return privileges. This guarantee shall only apply if the "Farm" is notified within one week of the foal's death. In all cases, the required Veterinary Certificate shall affirm that the Mare had been immunized for equine rhino pneumonitis during pregnancy and the date of such vaccination. Where appropriate, the certificate shall also confirm that the Mare was properly cared for during gestation and was attended at foaling. **The farm's timely receipt (within 10 days of examination) of the required Veterinary Certificates is a condition precedent to any right of return.**

The "Purchaser" shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees to hold the "Farm", owner, keeper or agent harmless for any and all damages associated therewith.
